1.0 SCOPE OF CONTRACT

The Contractor shall render professional services as required to provide complete renovation, finished, fully adjusted, tested and to improve technical security system [TSS] in the Embassy compound, provide recommendations and a cost estimate for the repair and coating of the interior of the tank(s) as needed, successfully perform the recommended repairs, and return the water storage tanks to service, and supervision as needed to complete the services that meet the technical requirements in this Statement of Work (SOW). It is expected that the Contractor shall partner closely with Embassy personnel.

The work shall be executed in a diligent manner in accordance with a negotiated firm fixed price and performance period. The period of performance for all Phases of the project shall be proposed by the contractor and agreed on by COR

The Contractor shall have limited access to or be admitted into any structure outside the areas designated for the project except with permission by the Embassy. The Contractor shall address the impact of the consequent disruption and provide for a continuing level of operation for continuous occupation of the residence during works.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is to provide professional services in accordance with Attachment A.
- B. The contract will be for a one-time period from the date of the contract award.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1.1 SURVEILLANCE.

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

1.2 STANDARD.

The performance standard is that the Government receives no more than one (3) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

1.3 PROCEDURES

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

SPECIFICATIONS/WORK STATEMENT

GENERAL SCOPE OF WORK

(1A) Overview

A-1. The Embassy Compound located at the 4th Circular Road Cantonment, Accra Ghana is requesting service of Hand-hole and Underground Conduit Construction.

The contractor shall perform all specified work required for this project, provide needed tools and Labor.

(1B) Intent

B-1. The purpose of this project is to provide complete renovation, finished, fully adjusted, tested and to improve technical security system [TSS] in the Embassy compound. The spirit as well as the letter of the specification shall be followed, and all the work shall be executed to the true intent and meaning of these specifications.

(1C) Discrepancies and omissions

C-1. It is the responsibility of the contractor to inform the Contracting Officer (CO) or the Contracting Officer Representative (COR) of any discrepancies in the specifications before signing the contract, default of which will make him responsible for any errors or omissions in the specifications even though these have been approved by the Embassy.

C-2. All costs incurred by any changes or alterations necessitated by any errors or omissions shall be on the contractors own expense without having the right to ask for any indemnity.

(1D) Quality of equipment, material and workmanship

D-1. All equipment/ tools provided by the contractor shall be new, free from defects and of the same type, standard and quality as set forth in the specifications. Contractor shall provide tools/ equipment box to ensure safe keep of his equipment and be responsible of loss or damage of tools as specified.

D-2. The contractor's employees responsible for the work shall be qualified technicians equipped with proper tools and having previous experiences in similar applications.

(1E) Coordination with other trades

E-1. The contractor shall plan and coordinate the work with all the trades in advance of requirements and shall provide all necessary resources to ensure compliance on this project. The contractor shall undertake to make, without extra charge, minor changes and modifications in the layout as needed to prevent conflict with work of the trades, or for proper execution of the work. Any extra cost incurred by lack of coordination on the part of the contractor shall be at his/her own expense.

(2) - SCOPE OF WORK AND GENERAL SPECIFICATIONS:

(2A) Design Drawing and Specification

A-1. Project Management and Engineering [PME], CO or COR will provide the design package and specification for the construction of the UNDERGROUND and HANDHOLES. Contractor shall review and understand the work involved and what's required to complete the project.

A-2. Contractor is responsible for reporting any error in the provided drawing to CO, COR or PME.

A-3. Contractor shall install the infrastructure for the HANDHOLE and UNDERGROUND CONDUIT as outlined in the drawing package.

A-4. Contractor shall provide a detailed project schedule, with start and end dates for work activity and stating a critical path. The COR will inspect progress and final approval of all work performed by contractor.

(2B) Site Preparation

B-1. Contractor will be responsible for cleaning and removing all debris from site to nearest authorized dumping facility.

B-2. Any damage caused by the contractor during work must be repaired or replaced back to the original. (e.g. grass, gravel, sidewalk, landscape, asphalt, electrical and water connections etc.)

B-3. Contractor shall limit the site disturbance to a maximum 6 feet (1829mm) on each side of trench. Excavated materials will be placed next to the excavated area to use as select backfill.

(2C) Trench

C-1. Contractor will verify existing utilities and provide AS-BUILT Drawings prior to excavation of Trench. If the excavation work interferes with drain or any piping, the contractor shall inform the COR or the CO for the Embassy to provide a suitable protection for these structures prior to proceeding of work. All trenches will be excavated to the required depth according to specification and conduit type as shown. Actual measurement will be taken during site visit.

C-2. Contractor shall install warning and safety signs to alert pedestrians and vehicle traffic of construction of trench. Also install barricade lines to cordon off work area around trench.

C-3. Dispose of excavated materials that will not be used to backfill trench to the approved location.

C-4. Contractor will make holes penetration to the existing manholes according to number of conduit entering and the existing manhole.

(2D) Conduit

D-1. All existing conduit should be left in-place. Under grass, dirt, sidewalk or asphalt, install schedule 80 PVC Conduit 42 inches [610mm] below finish grade to the top of the conduit as specified. All underground 90 degree bends with a 12inch (305) radius shall be made with pre-fabricated 90 degree sweeping bend.

D-2. ALL existing underground conduit shall be converted from schedule 80 PVC to RGS five feet before transitioning above ground using PVC to RGS couplers.

D-3. Contractor shall leave a pull line in all installed conduit paths. Also, install conduit from the HANDHOLE to HANDHOLE or the exterior pull box as shown.

D-4. All conduit stubbed and capped above the ground shall be at the height of not less than 12'' (305) from the ground. When the stubbed conduit is near a wall it must be at a least 2'' (51mm) from the wall to allow box to be mounted.

(2E) Concrete works

E-1. Contractor shall provide and cast concrete (c35- 40) on all approved chambers as shown in the drawing.

E-2. Concrete will be tested by the Facility Manager (FM) or COR before casting to ensure stability and safety.

E-3. Contractor use only approved concrete mechanical vibrating equipment supplemented by hand- shading, rodding, or tamping. Accrual volume of concrete will measured during site visit.

(2F) Soil material (Backfill)

F-1. Contractor shall provide hardcore material for backfilling... ASTM D 2487 soil classification group SW, SP, and SM or a combination of these group, free of rock or gravel larger than 3 inches in any dimension, debris, waste, frozen materials, vegetation, and other deleterious material.

F-2. Asphalt/ concrete base course: naturally or artificially graded mixture of natural or crushed gravel, crushed stone, and natural or crushed sand: ASTM d2940 with at least 95 percent passing an 1 1/2 inches sieve and not more than 8 percent passing 1 ¼ inch sieve.

F-3. Contractor shall ONLY use approved backfill/ hardcore material to fill the trench area same as the existing as specified in F1. Hardcore will be well compacted to avoid any damage.

F-4. Contractor shall fix all concrete slab, vegetation, asphalts, pavement and hand scape same as existing and indicated in 2F-2.

(3) - CONTRACT ADMINISTRATION

A-1. The Contractor shall not conduct any work that is beyond this Statement of Work and accompanying specifications unless directed in writing by the CO. Any work done by the Contractor beyond this SOW and accompanying specifications without direction from the CO will be at the Contractor's own risk and at no cost to the Embassy.

A-2. The CO shall provide a Notice to Proceed [NTP] to the Contractor. No work shall be initiated until the NTP is issued by the CO.

A-3. The CO may designate more than one individual to serve as the COR. The Contractor will be furnished evidence of COR appointments, including explicit authority delegated to each COR and their responsibilities.

A-4. The Embassy does not make representations or warranties of whatsoever kind or nature, either expressed or implied, as to the quality, level of completion, accuracy, extent of compliance with the standards, codes and requirements described or referred to in this SOW, or the extent of coordination between or among the documents provided to the Contractor.

A-5. The Embassy's review, approval, or acceptance of, or payment for the services required under this contract shall be construed to operate as a waiver of any rights under this contract or any cause of action against the Contractor arising out of the performance of this contract.

A-6. The Embassy has the right to inspect and test all services called for by the contract, to the extent practicable at all times and places during the term of the contract. The Facilities Office may perform quality assurance inspections [QAI] and tests during the work to confirm the work is according to the SOW.

A-7. The CO has the authority to issue a temporary stop order during the execution of any particular phase of this SOW. This authority may be executed when the Embassy requires time for official functions, or is in possession of specific credible information indicating that the lives of Embassy personnel are immediately threatened and that the execution of the project will increase the Embassy's vulnerability. The Contractor shall promptly notify the CO that work has been stopped.

A-8. If any of the Contractor's services do not conform to the contract requirements, the COR may require the Contractor to perform the services again in conformity with the contract requirements. The Embassy may by contract or otherwise, perform the services and charge the Contractor any cost incurred by the Embassy that is directly related to the performance of such service or terminate the contract for default.

A-9. The Embassy has the right to terminate this contract of convenience at any time in whole, or from time to time, if the CO determines it is in the interest of the Embassy

(4) - SITE VISIT

A-1. To help you submit a complete and accurate quote, a site visit will be held on May 18, 2018 at 0900, at U.S. Embassy, 4th Circular Road, Cantonments, Accra, Ghana. Please send names of representatives that would be attending this site visit to AccraGSOBids@state.gov no later than (NLT) 16:30 on May 15, 2018.

(5) - RESPONSIBILITY OF THE CONTRACTOR

A-1. Contractor shall provide all necessary tools/ equipment to complete the project as specified. Specifications of all tool/ equipment to be used must be given in the bid (include pictures and drawings if necessary).

A-2. The Contractor shall be responsible for the professional quality, technical accuracy, and the coordination of the work and other services furnished under this contract. The Contractor shall, without additional compensation, correct or revise any errors or deficiencies in its works and other services.

A-3. The Contractor shall identify a Project Site Manager who shall be responsible for the overall management of the project and shall represent the Contractor on the site during the work. The Project Site Manager shall be approved by the COR.

A-4. The Project Site Manager shall attend all project meetings, prepare Status Reports on the project and submit them to the COR. Status Reports shall contain meeting minutes, accomplishments, arising concerns and proposed solutions, any proposed changed orders, and any other pertinent information required to report the progress of performance.

A-5. All documentation produced for this project will become the ownership of the Embassy at the completion of this project.

A-6. Any cost associated with services subcontracted by the Contractor shall be borne by and be the complete responsibility of the Contractor under the fixed price of this contract.

A-7. The Contractor is responsible for safety and shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety and similar matters. The Contractor shall promptly report all accidents resulting in lost time, disabling, or fatal injuries to the COR.

A-8. The Contractor shall be and remain liable to the Embassy in accordance with applicable law for all damages to the Embassy caused by the Contractor's negligent performance of any of the services furnished under this contract. The rights and remedies for the Embassy provided for under this contract are in addition to any other rights and remedies provided by law.

(6) - PRE-WORK REQUIREMENTS

A-1. The Contractor shall examine all the documents and visit the site to fully inform themselves of all the conditions and limitations applied to the work and submit a firm fixed price cost proposal for all the work. No subsequent cost allowance will be made to the Contractor for neglect of the existing conditions.

A-2. Provide a statement that the Contractor's company and all personnel are experienced in construction services or similar to type and scope required for the work.

A-3. The Contractor shall prepare and submit a Quality Control Schedule [QCS] and Project Safety Plan [PSP] to address the project. The QCS and PSP are intended to document the entire project from beginning to end.

(7) - WORK REQUIREMENTS

A-1. No work shall begin until approvals of the Pre-work Submittals are accepted by the COR.

A-2. The Contractor shall be responsible for all required materials not provided by the Embassy, equipment and personnel to manage, administer, and supervise the project. All workmanship shall be of good quality and performed in a skillful manner as determined by the COR.

A-3. Equipment and materials shall be carefully handled, properly stored, and adequately protected to prevent damage before and during the work, in accordance with the manufacturer's recommendations. Damaged or defective items shall be replaced. The contractor will be responsible for security of all materials and equipment.

A-4. The Contractor will be provided with a storage and staging area as determined by the COR. The Contractor shall be responsible for restoring the area to its original condition at the completion of the work. The Contractor shall be responsible for repair of any damage incurred to buildings or pavement as a result of storage activities. The Contractor is responsible for obtaining any additional off compound storage areas as required.

A-5. The Contractor shall at all times keep the work area free from accumulation of waste materials. Upon completing the work, the Contractor shall remove all temporary facilities and leave the project site in a clean and orderly condition acceptable to the COR.

A-6. The Contractor shall perform the work at the site during the Embassy's normal workday hours, unless agreed upon with the COR.

A-7. At the end of each work day, or notification of a temporary stop order, the Contractor shall lower and fix all temporary work platforms and/or harnesses. Contractor shall notify the COR of the temporary barricade locations. Beginning the next workday, the contractor shall remove the temporary barricades before continuing the project.

A-8. Storm Protection - Should warnings of wind of gale force or stronger be issued, the Contractor shall take every practicable precaution to minimize danger to person, the work and adjacent property. Precautions shall include, but not be limited to, closing all openings, removing all loose materials, tools and equipment from exposed locations, and other temporary work.

A-9. Cleanup - The Contractor shall keep the work area, including storage areas, free from accumulations of waste materials on a daily basis and comply with all federal, state and local regulations pertaining to the storage, transport and disposal of wastes. The Contractor shall not use Embassy waste disposal facilities including garbage cans, trash piles or dumpsters.

A-10. Landscape Restoration - The surfaces of all unpaved areas disturbed by work activities shall be sodded with an approved grass native to the sodded area as approved by the COR. These shall include areas which existing pavement is removed, areas where excavation takes place, and areas where existing sod is killed or compacted by work activities. Landscape shrubs killed or damaged by work activities shall be replaced with same species and size.

(8) - CRITERIA

A-1. The Contractor work shall be in accordance with U.S. codes and standards. The COR will review and comment on the Contractor's submissions using the following codes and standards: American Society for Testing & Materials, 2003 International Building Code

A-2. Contractor shall have resident, registered/ certified/ licensed civil engineer or graduate architect on site or a qualified construction supervisor at all time, who should have at least two years' experience in similar work.

(9) - PROJECT SECURITY

A-1. The work to be performed under this contract requires that the Contractor, its employees and sub-contractors submit corporate, financial and personnel information for review by the Embassy. Information submitted by the Contractor will not be disclosed beyond the Embassy.

A-2. The Contractor shall submit this information including company vehicle requirements within 10 days of the Notice to Proceed.

A-3. Contractor must ensure that the Embassy compound equipment and property in the work zone or surrounding areas are protected to prevent any damage during construction. Should any repair or change have to be done due to negligence by contractor or its workers, contractor will be responsible for the cost incurred in the repair.
